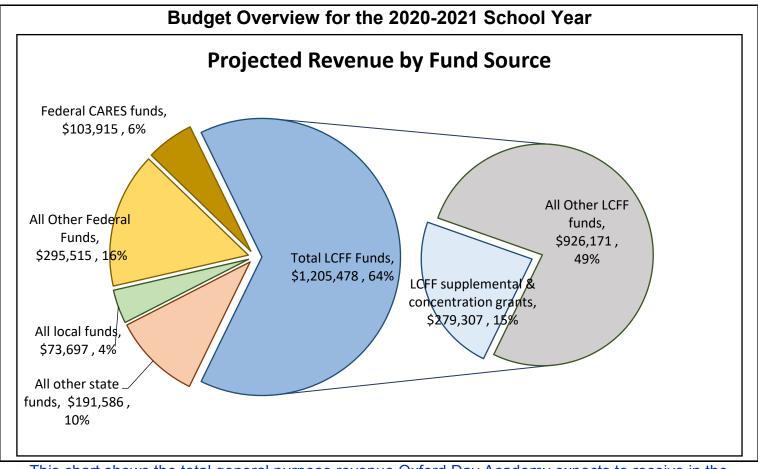

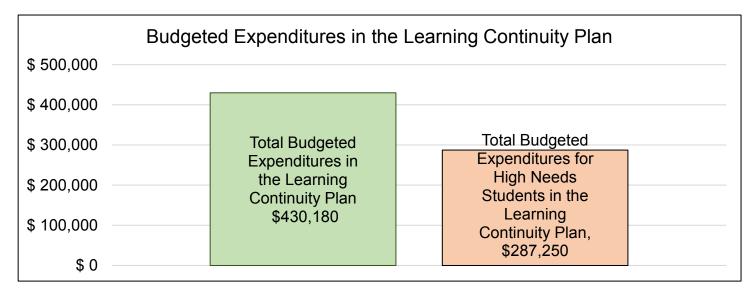


This chart shows the total general purpose revenue Oxford Day Academy expects to receive in the coming year from all sources.

The total revenue projected for Oxford Day Academy is \$1,870,190.50, of which \$1,205,478.00 is Local Control Funding Formula (LCFF) funds, \$191,586.00 is other state funds, \$73,696.50 is local funds, and \$399,430.00 is federal funds. Of the \$399,430.00 in federal funds, \$103,915.00 are federal CARES Act funds. Of the \$1,205,478.00 in LCFF Funds, \$279,307.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

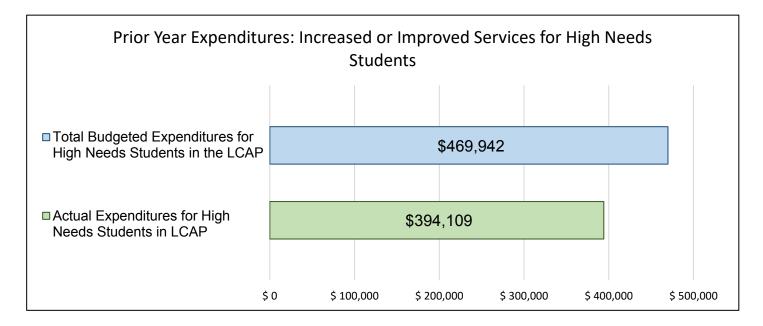

Increased or Improved Services for High Needs Students in in the Learning Continuity Plan for the 2020-2021 School Year

In 2020-2021, Oxford Day Academy is projecting it will receive \$279,307.00 based on the enrollment of foster youth, English learner, and low-income students. Update on Increased or Improved Services for High Needs Students in 2019-2020



This chart compares what Oxford Day Academy budgeted in the 2019-20 LCAP for actions and services that contributed to increasing or improving services for high needs students with what Oxford Day Academy actually spent on actions and services that contributed to increasing or improving services for high needs students in the 2019-20 school year.

In 2019-2020, Oxford Day Academy's LCAP budgeted \$469,942.00 for planned actions to increase or improve services for high needs students. Oxford Day Academy actually spent \$394,109.00 for actions to increase or improve services for high needs students in 2019-2020. The difference between the budgeted and actual expenditures of \$75,833.00 had the following impact on Oxford Day Academy's ability to increase or improve services for high needs students:
