#### Parents:

Parents were asked to give feedback regarding how the school can better assist their students with learning loss and account for lost instructional time. Parents were guided through a series of questions: what supports do you think your student still needs? what program offerings are working for your student? What program offerings are not as helpful? What program would you like toe see the school implement? What resources would you like to see offered through the school?

- Parents were shown a chart of all programs implemented since implementation of the expanded learning opportunities plan was implemented.
- The feedback reflects a desire to see the specified resources offered at the school a it relates to learning resources, college readiness supports and resources, and extra support for wellness:
- Evening classes and courses offered for college readiness

- Tutoring services offered outside of school and RTI (response to intervention hours)
- Parent support for accessing the school programs and tech
- Parent support for accessing the English language (ELD for parents)
- Sports and wellness programs to boost incentives and student motivation for attending school.

Teachers were asked to give feedback on the types of additional support they would like to see for this year and the next school year.

- Staff reports that they would like to see even more support in ELD instruction and planning.
- Hiring additional support staff to help with campus monitoring and campus life.
- Training on effectively teaching to the ODA instructional model
- Training on how to build a discipline policy around trauma-informed practice

The feedback received during the 2020-2021 school year through surveys, in relation to the LCAP and ELOGP was incorporated into the development of this plan, as it remains consistent with more recent feedback (per school culture & climate surveys) relating to the ESSER III Expenditure Plan. Identified areas of need from prior and current feedback are the focus of the ESSER III plan. The main areas of focus as determined by various segments of the school community are listed below. Item 1 is from responses/feedback/input given to ODA during the 2020- 2021school year and is carried over to this plan as we seek to incorporate mitigation strategies during the 2021-2022 academic year. Items 2-6 directly correlate to feedback received from various stakeholders regarding the needs for the 2021-2022 academic year. Stakeholders responded to a variety of questions regarding school safety, academic need, and additional resources, the action items in the ESSER III plan are a direct correlation of the feedback.

- 1. Ensuring access to interventions to mitigate learning loss are available to assist struggling students, students with disabilities, and English Learners;
- 2. Providing students with access to educational technology to maximize learning opportunities;
- 3. Providing students access to mental health services and supports;
- 4. Improving indoor air quality in the classrooms;
- 5. Repairing/improving the school facility to reduce the risk of virus transmission and exposure to environmental health hazards;
- 6. Ensuring the LEA continues to do what is necessary to maintain operations and continuity of services and continuing to employ

existing staff.

# **ESSER III Expenditure Plan Instructions**

#### Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
